- 2. Approval on the Company's profit appropriation for the financial year ended on December 31, 2024.
- 3. Appointment of the Public Accountant and/or Independent Public Accountant as registered at Financial Services Authority ("OJK") in order to audit the Company's financial report for the year 2025.
- 4. Determination of the salary, honorarium, and/or allowances for the Board of Commissioners and Board of Directors of the Company for financial year 2025.
- 5. Approval of the changes in the composition of the Company's Management.
- 6. Report on the Realization of the Use of Proceeds of the Company's Bond Public Offering and Sukuk Mudharabah.
